**2011 ANNUAL USBC TRI COUNTY YOUTH CHAMPIONSHIP TOURNAMENT RULES**

1. THIS TOURNAMENT WILL BE CONDUCTED IN ACCORDANCE WITH THE FOLLING RULES ADOPTED BY THE TRI COUNTY YOUTH LEADERSHIP.
2. **ELIGIBILITY**  
PARTICIPATION IN THIS TOURNAMENT WILL BE LIMITED TO SANCTIONED MEMBERS OF THE TRI COUNTY YABA ONLY.
3. **TIME PREFERENCE**  
ENTRIES WILL BE SCHEDULED IN THE ORDER RECEIVED.
4. **PARTICIPATION**
  - A. BOWLERS ENTERED IN THE DOUBLES EVENT MUST ENTER THE SINGLES EVENT.
  - B. BOWLERS ENTERED IN THE SINGLES EVENT MUST ENTER THE DOUBLES EVENT
  - C. SINGLES AND DOUBLES ENTRANTS DO NOT HAVE TO ENTER THE TEAM EVENT
  - D. TEAM EVENT ENTRANTS DO NOT HAVE TO ENTER SINGLES AND DOUBLES EVENT.
  - E. THERE WILL ONLY BE ONE ENTRY ALLOWED IN EACH EVENT PER BOWLERS, BUT BOWLERS WILL BE ALLOWED TO SUBSTITUTE ONCE PER EVENT.
  - F. BOWLERS NEED TO CHECK IN AT LEAST 45 MINUTES PRIOR TO BOWLING
5. **TOURNAMENT AVERAGE**
  - A. ENTRANTS WILL USE THEIR HIGHEST AVERAGE AS OF MIDNIGHT OCTOBER 6, 2010.
  - B. USING THE COMPUTER LIST PROVIDED BY THE TOURNAMENT DIRECTOR, ALL COACHES WILL ENTER THE AVERAGES OF ALL PARTICIPANTS IN THEIR LEAGUES.
  - C. ENTRY FORMS MUST BE SIGNED BY COACH
6. **HANDICAP**  
THE HANDICAP WILL BE 90% OF THE DIFFERENCE BETWEEN THE BOWLERS AVERAGE AND 210.
7. **ORDER OF BOWLING**
  - A. TEAMS WILL BOWL IN THE ORDER SUBMITTED ON THE ENTRY FORM.
  - B. SINGLES WILL BE BOWLED BEFORE DOUBLES
  - C. SUBSTITUTES WILL BOWL IN THE SAME PLACE IN THE LINEUP AS THE ORIGINAL BOWLER
  - D. SUBSTITUTES WILL BE ELIGIBLE FOR AWARDS IN ALL EVENTS BOWLED.
8. **ENTRY REQUIREMENTS**
  - A. ALL ENRIES WILL CLOSE AT MIDNIGHT OCTOBER 11, 2011.
  - B. ALL FEES MUST ACCOMPANY ENTRY FORMS
  - C. NO REFUNDS WILL BE MADE AFTER 10 DAYS FROM MAILING DATE OF SCHEDULE.
  - D. ALL CHECKS ARE TO BE MADE OUT TO TRI COUNTY USBC ASSOCIATION.
  - E. ANY RETURN CHECK FEES WILL BE ASSUMED BY THE SIGNER
  - F. ALL ENTRIES MUST BE COMPLETE OR THEY WILL BE RETURNED.
  - G. BOWLERS WHO DO NOT HAVE AVERAGE VERIFICATION FORMS ON FILE FOR 10/06/10 OR DO NOT HAVE A 12 GAME AVERAGE ON OCTOBER 9, 2011 WILL BOWL SCRATCH---(210 AVERAGE 0 HANDICAP)
9. **AWARDS AND DISTRIBUTION**
  - A. ALL AWARDS FEES WILL BE RETURNED 100%
  - B. ONE AWARD WILL BE PRESENTED FOR EACH EIGHT ENTRIES PER DIVISION
  - C. ONE AWARD WILL BE PRESENTED FOR FIRST PLACE SCRATCH IN EACH EVENT DIVISION

10. **SUBSTITUTES**
  - A. SUBSTITUTES MUST BE ON THE OCTOBER 11, 2011 AVERAGE FORMS
  - B. AVAILABLE SUBSTITUTES MUST CHECK IN 45 MINUTES PRIOR TO SQUAD TIME
  - C. THE TOURNAMENT DIRECTOR MUST BE NOTIFIED 24 HOURS PRIOR TO SQUAD TIME OF ANY CHANGES IN THE SCHEDULE EXCEPT FOR ACTUAL EMERGENCIES.
  - D. CHANGES ON THE COMPUTER SCORING TERMINAL WILL ONLY BE DONE BY A TOURNAMENT OFFICIAL... ANY OTHERS WILL RESULT IN A DISQUALIFICATION OF THE INDIVIDUAL AND OR/TEAM.
  - E. THE ENTRY WILL BE RE-REATED IF THE SUBSTITUTES AVERAGE DIFFERS FROM THE ORIGINAL BOWLERS.
11. THERE WILL BE NO USE OF TOBACCO PRODUCTS NOR WILL THERE BE ANY CONSUMPTION OF ALCOHOLIC BEVERAGE BY ANY PARTICIPANT IN THE TOURNAMENT.
12. TARDY BOWLERS WILL RECEIVE NO SCORE FOR FRAMES MISSED.
13. ALL BOWLERS WILL WEAR PROPER ATTIRE TO BOWL. THE TOURNAMENT DIRECTOR RESERVES THE RIGHT TO DISQUALIFY ANY BOWLER IN INAPPROPRIATE ATTIRE. (NO MIDDRIFTS SHOWING, NO HATS, AND NO SHORT SHORTS) ALL BOWLERS WILL WEAR APPROVIED (USBC) BOWLING SHOES.
14. **OFFICIAL SCORES**
  - A. THE TELESCORER WILL BE THE OFFICIAL SCORE DURING THE GAME AND THE OFFICIAL SCORE TABULATION SHEET WILL THEN BE AUDITED AND ERROR WILL BE CORRECTED.
  - B. ANY PROTEST INVOLVING SCORING OR RULES MUST BE CONFIRMED IN WRITING TO TRI COUNTY USBC NO LATER THAN (72) HOURS AFTER THE INCIDENT OCCURS. (COPY TO THE TOURNAMENT DIRECTOR)
15. MEMBERS OF TRI COUNTY USBC YOUTH SHALL CONDUCT THEMSELVES WITHIN THE STANDARD EXPECTED OF YOUTH BOWLERS. IF MEMBERS DO NOT ADHERE TO THESE RULES, THEY MAY BE SUSPENDED FROM FURTHER PARTICIPATION IN THE TOURNAMENT AND REPORTED TO USBC FOR FORMAL SUSPENSION.
16. ANY RULES NOT ADDRESSED IN RULES 1-16 WILL BE GOVERNED BY USBC TOURNAMENT RULES.
